

ORDINANCE S-45776

AN ORDINANCE DESIGNATING THE VOTING CENTERS  
FOR THE CITY OF PHOENIX SPECIAL ELECTION TO BE  
HELD ON AUGUST 27, 2019; AND PROVIDING FOR  
VOTING DAYS AND HOURS.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PHOENIX as  
follows:

SECTION 1. That the following places be, and the same hereby are,  
designated and shall be the voting centers for City of Phoenix Special Election to be  
held on August 27, 2019, as follows:

and on the day of election, Tuesday, August 27, 2019, from 6:00 a.m. until 7:00 p.m.

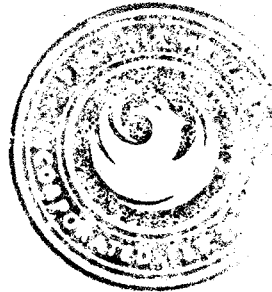
SECTION 4. That all other Ordinances and parts of Ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.

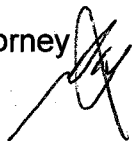

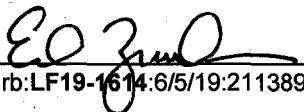
