

ORDINANCE G-5315

AN ORDINANCE RELATING TO SOLID WASTE FEES;  
AMENDING CHAPTER 27, ARTICLE VII, PHOENIX CITY  
CODE, BY AMENDING SECTIONS 27-48(D), 27-53(B) AND  
27-53(E)(2).

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PHOENIX as

follows:

1. Section 27-48(D), Phoenix City Code, is amended to read:

**Sec. 27-48. Level of solid waste fees; no exceptions.**

D. The monthly solid waste fees effective ~~January 13, 2008~~ MARCH 1, 2009, are as set forth below:

8. 6.	CUSTOMER REQUESTED Additional 300-gallon container for convenience	\$76.35 \$80.40 per container
9.	Additional 440-gallon container for convenience—	\$127.25 per container—
10. 7.	Per cubic yard service to: schools, churches, non-profit organizations agencies, multiple dwellings, City facilities	\$51.00 \$53.60 per cubic yard
11.	Per cubic yard collection and disposal services: roll-offs, bins, multi-family, apartments, or lots not serviceable with standard City solid waste equipment—	The Director will set fees based on quantity, type of collection and disposal costs—
12.	Manual solid waste collection fee—	The Director will set fees based on manual collection and disposal costs—

2. Section 27-53(B) is amended to read:

**Sec. 27-53. Solid waste disposal facility permits; fees.**

B. Commercial users must pay disposal fees ~~with cash~~ AT THE TIME OF DISPOSAL or establish a charge account. To establish a charge account, the commercial user must file with Public Works Department, Fiscal Services Section, a bond or cash deposit for the benefit of the City in the sum of not less than one thousand dollars. The amount will be adjusted upward according to user's average usage so that the bond or deposit will be the equivalent of three months charges to protect the City. The bond shall be executed by said commercial user or firm and by a surety company maintaining an agency in the City. All bonds or deposits shall be conditioned that the commercial user or firm named therein shall pay the disposal fees by the last day of the billing month. If not paid by the last day of the billing month, the Director shall refuse to allow the

commercial user or firm to charge any further disposal fees and will deduct all outstanding charges (including delinquent fees) from the bond or deposit established. If the outstanding debt is not satisfied through the bond or deposit, the Director may deny use of City disposal facilities to the debtor.

3. Section 27-53(E)(2) is amended to read:

**Sec. 27-53. Solid waste disposal facility permits; fees.**

E. For Class 1 solid waste, the following fee schedule shall apply:


2. GVW more than twelve thousand five hundred pounds and properly covered shall be charged the greater of ~~fifteen~~ TWENTY dollars or:

27th Avenue Solid Waste Management Facility	<del>\$36.25</del> \$38.25 per ton
North Gateway Transfer Station	<del>\$36.25</del> \$ 38.25 per ton
