ORDINANCE S-45537

AN ORDINANCE DESIGNATING THE VOTING CENTERS FOR THE CITY OF PHOENIX RUNOFF ELECTION TO BE HELD ON MAY 21, 2019; AND PROVIDING FOR VOTING DAYS AND HOURS; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PHOENIX as

SECTION 1. That the following places be, and the same hereby are, designated and shall be the voting centers for City of Phoenix Runoff Election to be held on May 21, 2019, as follows:

SECTION 3. That the voting centers shall be open for voting on the Saturday (May 18, 2019) before the day of election from 10:00 a.m. to 4:00 p.m., on the Monday (May 20, 2019) before the day of election from 9:00 a.m. to 6:00 p.m., and on the day of election, Tuesday, May 21, 2019, from 6:00 a.m. until 7:00 p.m.

SECTION 4. WHEREAS, the immediate operation of the provisions of this ordinance is necessary to meet the requirements for the printing of the Sample Ballot Pamphlet, an EMERGENCY is hereby declared to exist, and this ordinance shall be in full force and effect from and after its passage by the Council as required by the City Charter and is hereby exempted from the referendum clause of said Charter.

SECTION 5. That all other Ordinances and parts of Ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.
