

ORDINANCE NO. G-4207

AN ORDINANCE AMENDING SECTIONS 2-164(B) AND 2-165(B) OF THE PHOENIX CITY CODE RELATING TO THE DEVELOPMENT ADVISORY BOARD.

Whereas, on May 19, 1999 the City Council adopted ordinance No. G-4175 which established the Development Advisory Board; and

Whereas, the Council now wishes to amend Sections 2-164 (B) and 2-165 (B) of the Phoenix City Code relating to the membership of the Board.

NOW, THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE CITY OF PHOENIX as follows:

SECTION 1. That Article IX, Section 2-164(B) of the Phoenix City Code is amended as follows:

Sec. 2-164. Purpose And Formation

* * *

(B). The Board shall consist of ~~17~~ A MINIMUM OF 9 AND A MAXIMUM OF 21 members, of which at least ~~14~~ THREE QUARTERS OF THE APPOINTED MEMBERS shall be residents of the City of Phoenix. Three may be non-Phoenix residents of

Maricopa County, so long as they own or are employed by a business located in the City of Phoenix. All members shall be residents of the United States. The design professional and contractor representatives shall be selected to represent the greatest diversity practicable among the various architectural, engineering and contracting trades, disciplines and areas of practical expertise. The membership shall be composed of A MAXIMUM OF the following NUMBERS OF EACH TYPE OF MEMBER:

- 5 design professionals
- 5 contractors
- 3 City of Phoenix residents who represent residential neighborhood interests
- 1 city resident representing disability issues
- 1 developer/owner of residential projects
- 1 developer/owner of commercial /industrial projects
- 1 representative of a citywide organization of business interests
- 1 REPRESENTATIVE OF THE CITY OF PHOENIX FIRE DEPARTMENT
- 1 REPRESENTATIVE OF THE CITY OF PHOENIX POLICE DEPARTMENT
- 1 REPRESENTATIVE OF ORGANIZED LABOR
- 1 REPRESENTATIVE OF THE CITY OF PHOENIX PLANNING COMMISSION

- (C). The Board shall also include 7 5 non-voting members which shall include the Development Services Department director or his designee and 1 representative each from the following departments: ~~Equal Opportunity, Fire, Street Transportation, Planning, Neighborhood Services, Water Services.~~

SECTION 2. That Article IX, Section 2-165(B) of the Phoenix City Code is amended as follows:

Sec. 2-165. Membership And Terms Of Office



(B). The initial terms of office for members INITIALLY appointed in 1999 shall be as follows: one (1) design professional, one (1) contractor, and one (1) developer AND ONE (1) REPRESENTATIVE OF ORGANIZED LABOR shall serve a term of one year. Two (2) design professionals, two (2) contractors, one (1) developer/owner, and one (1) resident, ONE (1) MEMBER OF THE PHOENIX PLANNING COMMISSION, AND ONE (1) REPRESENTATIVE OF THE PHOENIX POLICE DEPARTMENT shall serve a term of two years. Two (2) design professionals, two (2) contractors, two (2) residents, one (1) resident representing disability issues, and one (1) business organization representative, AND ONE (1) REPRESENTATIVE OF THE CITY OF PHOENIX FIRE DEPARTMENT, shall serve a term of three years. All terms of office shall commence as of July 1, EXCEPT THAT THE


TERMS OF OFFICE FOR MEMBERS APPOINTED IN 1999

SHALL COMMENCE AS OF JULY 1, 2000.


