TO

SITE-SPECIFIC SUPPLEMENTAL AGREEMENT No. 002

TO

INTERGOVERNMENTAL AGREEMENT BETWEEN THE STATE OF ARIZONA.

DEPARTMENT OF PUBLIC SAFETY

(OPS Contract No. 2002-080, AG Contract No. KR2-0579TRN)

AND

THE CITY OF PHOENIX, INFORMATION TECHNOLOGY DEPARTMENT

(Agreement No. 98439)

ADPS Site: White Tank Mountains

Pursuant to the Intergovernmental Agreement between Arizona Department of Public Safety and City of Phoenix (the parties), entered into on June 3, 2002, the parties enter into this supplemental agreement. All provisions of the June 3, 2002 IGA are incorporated into this supplemental agreement.

This Amendment recognizes that the White Tanks site is already in existence and the Demonstration Project, which initiated its creation, is now complete.

The host agency is Arizona Department of Public Safety (ADPS) and the benefiting agencies are both ADPS and the Regional Wireless Cooperative (RWC) Members.

ADPS provided ten 700 MHz frequency pairs and funding not to exceed \$800,000 to cover the cost to purchase and install a new remote trunk site at White Tank Mountains and system interfaces between the Phoenix Regional Wireless Network (PRWN) and the Yuma Regional Communications System (YRCS). This was accomplished as part of a demonstration project which has been completed and discontinued. The ten frequency pairs have been returned to ADPS and the interface to the YRCS has been removed, but the White Tanks site continues to be used by the RWC.

ADPS will provide sufficient floor and tower space, power, and backup power, for the RWC's ten-channel, 700 MHz remote trunk site at the existing ADPS facility on the White Tank Mountains. ADPS will also provide T1 connectivity from White Tank Mountains to a co-located ADPS/RWC facility.

The above site sharing and transfer of funds is done in consideration for the following: The RWC will provide three (3) State Agency Talkgroups, in support of the Gang and Immigration Intelligence Team Enforcement Mission (GIITEM), Illegal Immigration Prevention and Apprehension Co-op Teams, and the Wireless Services Bureau. The RWC will also provide radio ID's and access for up to one hundred and fifty (150) State Agency subscribers to use these talkgroups.
